Dear Applicant,

IOV welcomes you to apply for grant of Institutional Membership. In accordance with the Bye-Law No. 6.F. of the amended Bye-Laws of IOV with effect from 01st April, 2020, the IOV is granting membership to the Institutions.

The Institution means

- A. Public or Local Body or Registered Company or University or College or Registered Society or Trust or any other such originations involved in Educational or training or research related activity and alike bodies.
- B. Partnership Registered Firm or Limited Liability Partnership firms or Partnership firms or Proprietorship or any such firms involved in Valuation or other related professional activities and alike bodies.

Listed below are the instructions for filling your application, correctness in filling of enclosed form will facilitate the processing of your application in a shorter time and save you from unwanted communication regarding enquiries made.

1. Fill in every column. No column is to be left blank. In case there is nothing to fill, write suitable remarks. Incompletely filled in application may deemed to be rejected.
2. Date and Signature should be given on page **2** and **4**.
3. Read the UNDERTAKING on page 2 carefully. If you have any doubts about the conditions, either clarify or not apply.
4. Conditions for Institution Membership

- (a) The Institution must be registered with relevant authority.
- (b) One of the objectives of the Institution should be Valuation or other related professional activities.
- (c) The Institution must have its Registered Office within India or abroad.
- (d) The Institution must have PAN with the Income Tax Department.
- (e) The Institution must have GST No.
- (f) Essential Documents to be submitted:
 - i. Certificate of Incorporation / Partnership Deed or any other document required for the purpose of registration.
 - ii. Memorandum of Association or any other relevant document stating the objects of the Institution.
 - iii. Latest Audited Balance Sheet of the Institution.
 - iv. PAN Card of the Institution.
 - v. GST No. of the Institution.
 - vi. Proof of the Registered Office.
 - vii. Resolution for authorization of Signatory.
 - viii. Undertaking mentioning that the Institution and its authorized signatory are not undergoing insolvency resolutions and not an un-discharged Bankrupt in the prescribed format.

Note:

- (a) Copies of all documents shall be self-attested.
 - (b) Your application will only be considered with above stated documents. In the absence of these documents, your application will be considered incomplete and may deemed to be rejected.
 - (c) For Foreign Institution or Foreign Authorized Signatory, the requirement of Aadhaar Card, PAN Card and GST No. will be in accordance with the respective country.
5. Send readable, visible and self-attested copies of the documents.
6. Grant of Membership shall be accorded on the approval of the Administrative Committee.

7. The Council shall have the right to cancel or suspend the membership without assigning any reason.
8. All the disputes or differences whatsoever arising shall be settled amicably otherwise provision of the Arbitration and Conciliation Act, 1996 shall attract. Further, any legal disputes with the IOV, all matters/disputes are subject to the exclusive jurisdiction of Delhi Courts only.
9. As per the recent government notification, GST has become applicable on all payments to the Institution. At present, it is 18% on all payments as payable to the Institution for the membership and other such transactions.
10. The applicant is advised to verify the eligibility criteria carefully and furnish true and correct information in the Application Form.
11. Director / Managing Partner / Authorized Signatory of Valuation Report of the applicant Institution, which is involved in Valuation activity, should confirm the required qualifications and experience as prescribed under Bye-Laws No. 6 of the Bye-Laws of the Institution of Valuers (IOV) or qualification and experience as laid down by any other regulatory body.
12. Any change of any kind in the constitution of the Institution should be informed in writing to the Institution of Valuers within 30 days of the change.
